Course Description: An in-depth study of the causes and investigation of all types and descriptions of fires from the fire science point of view.

Statement of Prerequisites: None

Goal: To give the students an overview of the fire causes and to develop an understanding of the roles of a fire investigator.

Outcomes:

To be able to complete a site safety assessment of a building involved in a fire.

To be able to conduct a systematic evaluation of a fire scene.

Student will use critical thinking and creativity in determining the origin and cause of fire.

Student will use the scientific method to properly examine, preserve and document the reporting of a fire.

Course Objectives: To use the scientific method along with critical thinking and creativity in determining the origin and cause of a fire along with documenting your findings.

Methodology: The course will be presented in a lecture format. Exercises will be utilized to gain practical knowledge of the fire investigations. I will try to present an actual fire investigation case at the end of every lecture. Since these are actual fires that have happened in our community, any information about the fire **MUST** remain confidential.
