**Course Description:** This course is designed to introduce students to the occupational therapy profession. As the history, scope of practice, objectives and functions of occupational therapy are addressed: students will affirm their academic decision.

**Statement of Prerequisites:** None

Goal: Upon completion of this course students will be develop an understanding of

- 1. how the occupational therapy profession developed
- 2. the scope of practice of occupational therapy as related to special needs populations
- 3. the continuing trends in the profession of OT interventions

Students will be introduced to important concepts such as communication, problem solving and interactive skills used in the OT profession.

**Outcomes:** Upon completion of this course students will be able to:

- 1. (ACOTE B.2.1.) Articulate an understanding of the importance of the history and philosophical base of the profession of occupational therapy.
- 2. (ACOTE B.9.2.) Demonstrate knowledge and understanding of the American Occupational Therapy Association (AOTA) Occupational Therapy Code of Ethics and Ethics Standards and AOTA Standards of Practice and use them as a guide for ethical decision-making in professional interactions, client interventions, and employment settings.
- 3. (ACOTE B.9.13.) Demonstrate professional advocacy by participating in organizations or agencies promoting the profession (e.g., AOTA, state occupational therapy associations, advocacy organizations).
- 4. Demonstrate awareness of the process of therapeutic activity.
- 5. Demonstrate professional written communication skills.
- 6. Select, grade and adapt the environment, tools, materials, occupations, and interventions to reflect the changing needs of the client and the sociocultural context appropriate for the developmental age level and handicapping condition.
- 7. Demonstrate an understanding of various diagnoses and conditions seen by OT.

- 8. Demonstrate an understanding of aspects of professionalism in OT, the importance of AOTA and education, as well as role delineation of the OT/OTA professionals.
- 9. Demonstrate beginning problem solving skills related to OT intervention.
- 10. Identify and explain the need for supervisory roles, responsibilities, and collaborative professional relationships between the OT and the OTA.
- 11. Demonstrate effective oral and written communication.
- 12. Solve problems using critical thinking and creativity.
- 13. Demonstrate knowledge of diverse cultures and historical perspectives.

Casper College may collect samples of student work demonstrating achievement of the above outcomes. Any personally identifying information will be removed from student work.

**Methodology:** Learning experiences to be used in this class include lectures, unit assignments, field visits, interactive projects, reading assignments from textbook and problem solving activities.

Section I provides the student with an approach to defining Occupational Therapy (OT). The philosophy of OT is introduced as well as a review of the developmental history of the profession. An introduction to the education for OT practitioners is provided as well as a look at the professional organizations: American Occupational Therapy Association (AOTA) and the delineation of roles within the profession. At the completion of Section I the student will be able to:

- 1. Verbalize a working definition of OT
- 2. Discuss the philosophical base of OT
- 3. Verbalize knowledge of the education process of OT practitioners
- 4. Demonstrate an understanding of AOTA; how it operates, services provided and organization structure
- 5. Discuss the role delineation of OT, OT assistants and OT aids.
