Course Description: Thirty hours per credit of hands-on experience observing/assisting/instructing in various physical education activities: swimming, fitness, gymnastics, adaptive physical education, elementary physical education and coaching.

Statement of Prerequisites: Permission of the instructor

Goal: To provide students the opportunity to explore various disciplines within physical education.

Outcomes:

- 1. Demonstrate effective oral and written communication
- 2. Appreciate aesthetic and creative activities
- 3. Describe the value of personal, civic, and social responsibilities

Course Objectives: Upon completion of this course, the student will be able to:

- 1. Gain a better understanding and appreciating of the work involved in their desired area of specialty
- 2. Attain skills specific to their desired area of specialty
- 3. Analyze their desired area of specialty and explore other areas or the in more depth

Methodology: Observations and participation

Evaluation: The student will submit a plan for thirty to sixty hours of hands-on experience observing, assisting or instructing at an acceptable activity in the community of Casper. The student and instructor will select an area of interest. Grades will be determined via the following:

- **1.** Administrative forms. Students must complete and submit a liability form, Independent Study form, and Supervisor Information/ Agreement form within the first 2 weeks of the semester.
- 2. Pre-participation paper. Students will write a paper describing their expectations of the field experience.
- 3. Daily logs. Students will log their hours and describe what they did each day. <u>These must be</u> provided to the instructor once a week.
- 4. Final reflective paper. Students will write a final paper summarizing their experiences, what

they learned, how it will benefit them in the future, etc.

5. Signature of completed hours. Students will have their supervisor sign off on all completed hours. Failure to complete all required hours (30 or 60) will result in failing the course.
