Course Description: Individualized investigation of selected topics under the supervision of a faculty

member.

Statement of Prerequisites: MUSC 2040 and instructor's permission.

Goal: To apply principles of melody, counterpoint, harmony, and form to the analysis of selected pieces of music, thereby observing concrete examples of musical meaning arising from constituent musical elements.

Outcomes: Upon successful completion of this course, students will be able to:

- 1. Perform harmonic analyses of works of music;
- 2. Analyze the interactions of scales, chords, and macroharmonies;
- 3. Identify elaborations upon basic structures such as motives, sentences, simple forms, counterpoint, and schemas;
- 4. Articulate how composers combine various musical elements to create style and meaning.

Methodology: Students will meet with the instructor once weekly for a one-hour discussion; in addition to the discussion, students are expected to spend at least half an hour every day practicing their analytical skills via score study, listening, and analytical writing (for at least three hours per week outside of the discussion). Your feedback is valuable as I take course evaluations into account when determining course methodology.

Evaluation Criteria: Your grade in this class will be derived from a combination of attendance and assignments and a final project (exact balance listed below). Furthermore, to pass this course, you must receive no lower than a 60% in either of the two grade categories.

- 1. Attendance and assignments: worth 50% of your final grade.
- 2. Final project: worth 50% of your final grade. You will select a piece of music that has a special personal meaning for you and analyze it using the various techniques and approaches applied to the pieces examined throughout the semester. You will present a summary of your analysis during the final exam time, and hand in a paper and marked score showing the details of your analysis.

Required Text, Readings, and Materials: Scores provided by the instructor and/or printed from the International Music Score Library Project (ismlp.org). You will, of course, also need a pencil and blank staff paper (free staff paper can be printed from the website www.blanksheetmusic.net).

Class Policies: I run my classroom via two general rules:

- 1. Be Respectful: Treat your professor and colleagues with courtesy and respect, and don't do anything that disrupts the learning environment.
- 2. Be Responsible: Attend class (after all, you're still paying for me to teach you whether or not you show up), pay attention, ask questions and come to my office hours when you don't quite understand something, and always do your very best work on your assignments.
