**Course description:** Provides approximately 50 hours of flight instruction (35 hours dual, 15 hours solo flight). Students will receive an S/U grade after completion of the final check flight.

**Statement of prerequisites:** Concurrent enrollment in AVTN 2510 and third-class medical certificate.

**Goal:** Meet or exceed FAA Standards for the Private Pilot Certificate and pass the FAA Private Pilot Practical Test.

**Outcomes:**

1. Demonstrate ability to fly aircraft without any help.

**Methodology:** One on one aircraft training as well as solo aircraft training.

**Evaluation criteria:** Students will be given a grade of S/U based up completion of the FAA Private Pilot Practical Test.

**Casper College may collect samples of student work demonstrating achievement of the above outcomes. Any personally identifying information will be removed from student work.**
