Course description: Approximately 70 hours of advanced flight instruction teaching abilities such as altitude instrument flying, instrument navigation, and commercial cross-country flight. Students will receive an S/U grade after completion of the final check flight.

Statement of prerequisites: AVTN 2720.

Goal: Meet or exceed FAA Standards to take and Pass the FAA Commercial Pilot Practical Test.

Outcomes:

1. Demonstrate advanced commercial flying of aircraft.

Methodology: One on one aircraft training as well as solo aircraft flight training.

Evaluation criteria: Students will be given a grade of S/U based upon completion of the FAA Commercial Pilot Practical Test.
