Course Description: This course focuses on the importance of ethics in business considerations as well as ethical issues in the news today. This course will examine how ethics is an essential part of all business elements, from management to employee development.

Program goals:

Course Goal: This course is designed to introduce you to business ethics and the issues faced by mangers, employees and organizations. The purpose of this class is to provide students with frameworks for institutionalizing ethics in an organization, the decision making progress, and for implementing an ethics program.

Course Objectives - The student will:

- Demonstrate an understanding of the importance of business ethics, stakeholder relationships, social responsibility, and corporate governance.
- Become more aware of current ethical issues in business
- Develop and understanding of the decision making process as it relates to individual factors, organizational factors.
- Demonstrate an understanding of the framework for developing and implementing an effective ethics program.
- Demonstrate their understanding of the course material through class discussion (participation), examinations, papers, and presentations.

Methodology: Teaching/learning methods will include reading assigned chapters from the text, case analysis, class discussion and debate, lectures, projects/papers, presentations, and examinations. Unit exams may include topics from the assigned cases during that unit as well as any student presentations.
