Course Description: A study of the principles of agency and employment law, independent contractors, wrongful termination, worker's compensation, civil rights legislation, administrative law, environmental law, antitrust, partnerships, limited partnerships, joint-ventures, corporations, subchapter S corporation, limited liability companies, franchises, security regulation, lender liability and consumer protection, and international law.

Statement of Prerequisites: BADN 2010 – Business Law I or equivalent, advances business student.

Goals and Outcomes: This course will familiarize the student with the specific laws relevant to the business environment and business transactions. Emphasis will be placed on the legal formation of various business entities, including corporations, limited liability companies, partnerships as well as the legal relationship between entities and employees, agents, and independent contractors including wrongful termination and discrimination.

Methodology: The format for this course will be online with an emphasis on posted discussion of relevant problem areas or cases and assignments.

Evaluation Criteria: Grades in this class will be based on participation, the four exams, ten quizzes, and one writing assignment. A breakdown of the assignments and exams in this course is provided below.

<u>Four Exams</u>: There will be three regular exams and one final exam. Each exam is worth 100 points. Each exam has a 90 minute time limit. I will drop your lowest test score at the end of the semester.

Makeup exams will not be given because the final is intended to act as a makeup. Each exam will consist of True/False, Multiple Choice, and Short Answer Questions. Further, no exam date extensions will be given unless the circumstances are very grave.

Exams are open book and open note. Exams will remain open for one week. It is the student's responsibility to check the open and close dates on Moodle for each exam.

The final exam will be comprehensive and will cover all of the material studied during the semester.

The instructor reserves the right to apply a curve to the exam at his discretion. Curves will never hurt a student's grade.

<u>Eight Quizzes:</u> There will be eight quizzes over the course of the semester. Quizzes will consist of True/False and Multiple Choice questions. Quizzes are open note and open book. Each quiz will have a 50 minute time limit. The lowest quiz grade will be dropped at the end of the semester. Students will not be allowed to make up missed quizzes. No extensions to quiz dates will be allowed unless the circumstances are very grave.

Quizzes are open for two weeks so that students will be able to balance learning the material presented in each section with taking the quiz.

<u>Writing Assignment:</u> Each student will write a research paper on any topic covered in class that catches their interest. This paper will be 6-8 double spaced pages in length, written in a 12 point font, and will cite at least five reliable sources. All papers must include a cover page, which does not count toward the minimum page length, a properly constructed bibliography, and proper in text citations. Any paper missing these elements will lose 10 points for each. Papers are worth 25% of the student's final grade. Late papers will lose one letter grade for each day they are late. The instructor will open a dropbox on Moodle that students must submit their paper to.

Papers are due November 27th 2015 by midnight.

<u>Time Deadlines:</u> All timed quizzes, exams, and assignments are due by midnight Mountain time on the posted due date. Make sure you resolve any technical issues before this deadline expires.

<u>Forum Discussion</u>: Students are expected to participate regularly and seriously in forum discussions. While these discussions are not graded there will be opportunities for extra credit on quizzes and other incentives for students to participate. Further, students that participate are the ones who will get the most out of this class. Discussion for each week will begin on Sunday and will continue through the following Monday. This is so that students who cannot participate during the week may do so on the weekend. Students must contribute during this period of they want to receive attached extra credit. The instructor will provide feedback or discussion wrap-up as necessary.
