**Course Description:** Designed to integrate information processing and advanced level database problems and to create applications for the modern business environment.

**Statement of Prerequisites:** CMAP 1805, Database APP II or permission of the Flex Lab instructor.

**Goal:** Upon successful completion of this course, students will demonstrate the ability to develop accurate, reliable databases for a variety of business applications and use critical thinking skills to independently design and create tables, queries, forms, and reports of advanced complexity.

**Objectives and Outcomes:** Successful completion of this course will enable students to:

- Create, organize, edit and extract data in database files
- Link Access data to Excel worksheets and Word documents
- Build and modify multiple tables and forms
- Refine queries including cross-tab queries, make-table queries, and update queries
- Produce well-designed, professional looking reports
- Define relationships
- Utilize web capabilities
- Create an Access switchboard along with accompanying macros

**Casper College General Education Outcomes:** As graduates of Casper College, students will be able to:

2. Use the scientific method
3. Solve problems using critical thinking and creativity

**Methodology:** This course is self-directed which means, students work at their own pace with an instructor present to provide guidance and answer questions. Students will attend a mandatory orientation session to receive class material and directions for successful completion of the course. Students are expected to make continual progress toward the completion of the course so that the course will be completed during the

semester.

**Evaluation Criteria:** Grades will be computed on a point scale and weighted. Points will be totaled at the end of the semester and a percentage grade computed. Your final grade will be weighted as follows:

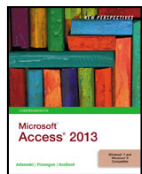
- 35% Homework assignments
- 30% Quizzes
- 25% Final Exam/Project
- 10% Subjective Factor\*

\*An assessment of class attendance, cooperation with others, class participation, attitude, initiative, and the ability to get your work in on time. Employers consider such factors to be of vital importance in evaluating employee job performance. Therefore, the letter grade you earn will reflect this aspect of your work.

Grades are calculated using a grading software program to allow for the above categories and their associated weights. You will receive a midterm and final grade for the course. If you submit files through Moodle, your grade will be recorded in Moodle but keep in mind the grades you see in Moodle do not reflect the subjective factor of your grade or the category weights. The grading scale is as follows:

2	Assignment has numerous errors including spelling/ grammar errors
0	No work submitted or incorrect file submitted.
