Course Description: This class focuses solely on internetworking fundamentals and is not specific to Cisco products or technologies. Student learning will include an understanding of the OSI internetworking model, internetworking components, premises wiring, industry standards, networking topologies and designs, and professional practices. Project learning experiences include designing campus networks and the installation of network premises cabling. Successful completion of this course can lead to Network + certification.

Goal: With appropriate study and preparation students will be able to list and describe the responsibilities of a network administrator, describe the hardware and software essential to network connectivity, use binary notation, practice IP addressing, and understand the functions and technologies associated with the OSI networking model.

Outcomes: Thoroughly understand the purpose and contents of the OSI and TCP/IP networking models; be able to explain clearly how networks are constructed, both individually (LANs and WANs) and as internetworks; list and explain the protocols and devices used to create common interworks; address networks at both the LAN and Internet levels; and explain the role of encapsulation in networking and demonstrate multiple cases of its use.

Methodology: This course employs a combination of lectures, demonstrations, discussions and hands-on labs. You are expected to **thoroughly read** the corresponding chapter in the text **before the lectures**. Quizzes and tests are comprehensive and include multiple question formats. Make-up tests may be permitted with prior arrangement with the instructor but may be denied at the discretion of the instructor for such things as poor homework or attendance record.

My best suggestions for succeeding in this class are:

- 1. Attend class.
- 2. Read the chapter BEFORE class
- 3. Complete the homework.
- 4. Ask questions
